Eco-friendly birdhouses can be functional or decorative and must be constructed of non-toxic materials that can withstand the outdoors. Treated wood is toxic and will not be accepted.

Entrants:

Youth ages 5-12 Teen ages 13 - 17 Adult ages 18 and over Unfinished starter kits from craft stores will be acceptable starts. All work must be done by the entrant within the past 12 months.

Judging Criteria:

Quality of Construction Style and Organization Attention to Theme 0.5 point deduction for start kit usage
